### **Jason Benton**

Jason Benton is a skilled litigator with experience, including trial work, in a wide variety of practice areas. He has been with Hughes Hubbard since he graduated from law school in 2000. Mr. Benton received his B.A. from Colgate University in 1991 and his J.D. in 2000 from Columbia Law School, where he was an editor of the Columbia Law Review, a Stone Scholar, a Kent Scholar and won the James A. Elkins Prize in Civil Procedure.

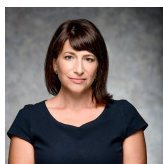
## **Hagit Elul**
