Prior to joining Kaye Scholer, Bell worked with Hughes Hubbard Antitrust and Competition Practice co-chair

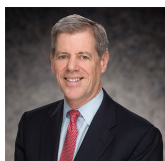
William Kolasky at WilmerHale where they were partners and Kolasky was chair of that firm's antitrust practice.
